In Salon Bridal Pricing:

Up do/ trial- \$60 (Bring veil or head pieces)

Bridal Styling \$125

Brides maids -*\$60 -80 *depending on the length, density and desired style

Blow dry styling short hair-\$40

*Prices may vary depending on the length and density of the hair

On-site Bridal pricing:

Bridal Hair: \$125.00

Blow Dry/set/style short hair: \$50.00

Bridal Party Prices for Hair: \$80.00

Hair stylist day fee-\$300

****On site bridal services require a party of 5 or more, if you have a smaller party we require a day fee for each service provider.

****A 20% gratuity will be added automatically to all services
